FOURTEENTH ASSEMBLY-FIFTEENTH SESSION

RESUME OF BUSINESS TRANSACTED BY THE BIHAR LEGISLATIVE ASSEMBLY

**FROM 19<sup>TH</sup> JULY, 2010 TO 23<sup>RD</sup> JULY, 2010**

### **1. SUMMONS**

Summons for the Fifteenth session of the fourteenth Bihar Legislative Assembly were issued to the Hon'ble Members of the Legislative Assembly on 29.06.2010 to meet at 11.00 a.m. on 19.07.2010.

### **2. DURATION OF 15<sup>TH</sup> SESSION**

The fifteenth session of the 14<sup>th</sup> Bihar Legislative Assembly commenced on 19<sup>th</sup> July, 2010 and adjourned sine die on 23<sup>rd</sup> July, 2010.

### **3. SITTINGS OF THE ASSEMBLY**

The Bihar Legislative Assembly held its sitting for five days during the period from 19<sup>th</sup> July, 2010 to 23<sup>rd</sup> July, 2010 on the following dates:-

19<sup>th</sup>, 20<sup>th</sup>, 21<sup>st</sup>, 22<sup>nd</sup> and 23<sup>rd</sup> July, 2010.

In terms of hours the House sat for 790 minutes i.e. 13 hours and 10 minutes (approx) only.

### **4. WELCOME ADDRESS AND CONSTITUTION OF BUSINESS**

#### **ADVISORY COMMITTEE AND PANEL OF PRESIDING MEMBERS**

In the beginning of 15<sup>th</sup> session on 19<sup>th</sup> July, 2010, the Hon'ble Speaker welcomed the Hon'ble Members of the Assembly and sought their help and cooperation in conducting the business of the House peacefully and smoothly. Thereafter the Hon'ble Speaker announced the names the Hon'ble Members of the Assembly constituting the business advisory committee for the session. The Hon'ble Speaker also announced the names of five senior Hon'ble Members of the Assembly constituting a panel of presiding members, any of them might preside over the Assembly in the absence of the Hon'ble Speaker in the Assembly in accordance the arrangement made by him in this behalf.

## 10. FINANCIAL BUSINESS

On 19.07.2010, Sri Sushil Kumar Modi, Hon'ble Minister-in-charge, Finance presented the first supplementary statements of expenditure for the year 2010-2011.

The discussion on the second supplementary statement of expenditure for the year 2010-2011 took place in the House on 22.07.2010. All together 66 cut motions were received out of which on scrutiny 60 were admitted and one of said cut motions against the demand of Agriculture department was moved in the House. Eight Hon'ble members took part in the discussion. The Hon'ble Minister-in-charge, Agriculture department replied to the debate. After reply, the cut motion was rejected and the demand for supplementary statement for expenditure of the Agriculture department was put on voting and it was accepted by the House. Thereafter the rest demands for supplementary grants were taken through the process of guillotine and were accepted by the House.

The Appropriation Bill relating to first supplementary statements of expenditures for year 2010-2011 i.e. Bihar Appropriation (No. 3) Bill, 2010 was

introduced in the House by the Hon'ble Minister-in-charge for the Finance. The same was also considered and passed on the same day i.e. on 22.07.2010.

### **11. DECLARATION MADE BY THE HON'BLE SPEAKER ABOUT ACCEPTANCE OF NIVEDAN**

During the period, the Hon'ble Speaker made declaration on 21.07.2010 and 22.07.2010 about the accepted NIVEDAN and with the consent of the House 3 each day all total 6 NIVEDAN were sent to the NIVEDAN COMMITTEE for enquiry and report.

### **12. LAYING DOWN OF PETITIONS (YACHIKA) ON THE TABLE OF THE HOUSE**

On 23.07.2010, with permission of the Hon'ble Speaker, the Assembly Secretary laid 5 petitions (Yachika) of general public importance on the table of the House to be sent to the Committee on Petitions (Yachika Samiti) for consideration and report.

### **13. PRIVATE MEMBERS BUSINESS & RESOLUTIONS**

On 23.07.2010 notices of resolutions were taken up. All together 34 out of 37 resolutions were put up for consideration. 14 resolutions were withdrawn by the respective Hon'ble members in view of the assurances given by the Hon'ble Ministers of the respective departments. One resolution was accepted by the House and rest could not be taken up as the Hon'ble members concerned were either absent or suspended.
