Dear Shri

I take this opportunity to apprise you briefly about the business transacted during the 1st Session of the 15th Bihar Legislative Assembly after the General Election which was held in September-October, 2010.

The Session commenced on Tuesday the 30th November, 2010 with the inaugural address made by Hon'ble Speaker Protem Shri Sadanand Singh and was adjourned sine die on 9th December, 2010 by Hon'ble Speaker Shri Uday Narayan Choudhary. Although 8 (Eight) sittings were held in this Session.

Oath or Affirmation

In this 15th Bihar Legislative Assembly, Shri Sadanand Singh, a senior member was appointed as Speaker Protem. He took Oath before the Governor at Raj Bhawan on 29th November, 2010. He was also appointed by the Governor to be the person before whom the newly elected members would take Oath before taking their seats. All 243 newly elected members, took Oath during the Session in the House.

Election of Speaker

2nd December, 2010 was the date fixed by the Governor for holding the election of the Speaker.

Shri Uday Narayan Choudhary a senior member of Janta Dal (U) party was unanimously elected as the Speaker of the 15th Bihar Legislative Assembly. Shri Choudhary is the second legislator who has been elected as Speaker of Bihar Legislative Assembly for two consecutive terms.

Governor's Address

The first Session after the General Election, His Excellency, the Governor of Bihar, Shri Devanand Kanwar addressed the joint Session of the members of Bihar Legislative Assembly and Bihar Legislative Council assembled at 11.30 AM on 3rd December, 2010. A notice for vote of thanks for the Governor's Address was moved on the 6th December, 2010 by Shri Shrawan Kumar, MLA. The motion was discussed on 6th-27th December, 2010. At the end of discussion and reply made by the Hon'ble Chief Minister Shri Nitish Kumar, the motion was passed by the House in its original from rejecting all the amendments tabled thereto.

Questions

In this Session, a total of 26th Short Notice questions and 92 unstarred questions were accepted out of which 25 questions were answered on the floor of the House.

Petition

During this Session, 18 petitions were received out of which 4 were presented in the House.

<u>Nivedan</u>

In this Session, 54 Nivedans were received out of which 28 were admitted and sent to the concerned department for reply.

Calling Attention Motion

In this Session, 59 Notices of Call Attention were received out of which 8 were answered in House.

Zero Hour

Several issues of Public Interest were raised by the Members in Zero Hour and sent to the concerned department for their reply.

Financial Business

The statement of 2nd Supplementary Expenditure for the year 2010-11 was presented to the House on 3rd December, 2010 by the Minister-in-Charge of Finance, Shri Sushil Kumar Modi. The statement including the demands were discussed and passed by the House on the 8th December, 2010. The concerned Appropriation Bill (No.-4), 2010 was passed by the House on the same day.

Government Bill

One Government Bill "The Bihar Appropriation (No.-4) Bill, 2010 was passed by the House during the session.

Assent Bill

The Secretary, Bihar Legislative Assembly reported to the House the assent of the Governor on the three Bills mentioned below which were passed by the 14^{th} Bihar Legislative Assembly during its 15^{th} Session :-
