Dear Shri .....

I take this opportunity to apprise you briefly about the 3<sup>rd</sup> Session of the 15<sup>th</sup> Bihar Legislative Assembly which commenced on 15<sup>th</sup> July, 2011 and was adjourned sine-die on 21<sup>st</sup> July, 2011. The House held 04 sittings.

**Oath or Affirmation**

Smt. Kiran Devi, newly elected member from Constituency No.-62 (Purnea) in Bihar Legislative Assembly bye-election 2011 took oath on the first day of the 3<sup>rd</sup> Session.

**Assent to Bills**

A statement concerning the assent of HE the Governor of Bihar to Twelve Bills passed during the Second session was stated by the Assembly Secretary.

**Assent withhold to Bill**

A statement concerning the assent withhold by HE the Governor of Bihar to three bills passed during 2<sup>nd</sup> Session of 15<sup>th</sup> Assembly was also stated by the Assembly Secretary.

**Financial Business**

The 1<sup>st</sup> supplementary demands for grants for the year 2010-11 were presented before the house on 15<sup>th</sup> July, 2011. Discussion and voting on this supplementary demands for grants was passed by voice vote on 20<sup>th</sup> July, 2011 and the concerned Appropriation Bill was passed on the same day.

### **Legislative Business**

During the session, following Bills were introduced, considered and passed by the House :-

### **Petitions**

During the session 41 petitions were received out of which 32 were accepted and presented in the House. Out of 41 petitions 9 were rejected.

### **Nivedan**

In this session 53 Nivedans were received out of which 37 were admitted and sent to the concerned department for reply and rest 16 were rejected.

### **Calling Attention Motions**

87 notices for Calling Attention Motions were received out of which 6 were accepted for oral replies and 65 notices were sent to the concerned departments for written replies. Out of 87 notices 16 notices were rejected.

### **Zero Hour**

Several issues of Public Interest were raised by the Members in the House during Zero Hour.

### **Private Member Resolutions**

During the session, 83 notices of Private Member Resolutions were received out of which 74 were accepted and 9 were rejected. Out of accepted notices, 72 were withdrawn in the House and 2 were accepted by the House.

### **Announcement from the Chair**

Hon'ble Speaker announced the consensus of the party leaders in which it is decided that Hon'ble Members will submit their declaration of movable & Immovable assets every year on 31<sup>st</sup> December to the Legislative Secretariat in Performa Prescribed by Election Commission.
